Project Update: Availability of Draft Environmental Impact Statement

ENVIRONMENTAL IMPACT STATEMENT

The Surface Transportation Board's Office of Environmental Analysis (OEA) is pleased to announce that the Draft Environmental Impact Statement (Draft EIS) for the proposed acquisition of Kansas City Southern Railway (KCS) by Canadian Pacific Railway (CP) is available for review. The Draft EIS analyzes the potential environmental impacts of the proposed acquisition, including impacts related to expected increases in rail traffic ranging from 8 to approximately 14.4 additional trains per day, on average, on CP and KCS rail lines between Chicago, Illinois and Laredo, Texas.

OEA will hold public meetings and receive comments from the public. The meeting schedule, instructions for submitting comments, and other project information are available below and on the Board-sponsored project website at www.CP-KCSMergerEIS.com.
